## 2016 ORR'S FALL FARM FUN DAYS CELEBRATION

### RULES ON ENTRY

1. All work must be suitable to a family-oriented show. We reserve the right to remove any exhibit not complying with these rules and regulations.
2. Please list **ALL ITEMS YOU PLAN TO SELL** on your application. We will try our best to limit duplicate items as much as possible. We will ask you to put items away at the show if they are not listed on your application and someone else is already selling them.
3. Booths are to be reserved in your name only. Exhibitors cannot sub-lease assigned booths; however, you may share a booth.
4. All exhibitors are expected to provide enough stock for the entire show, set up before show hours and remain open until closing time. All exhibitors must remain open until 5:00 on Saturday and 4:00 on Sunday.
5. Set up may begin after 4 p.m. on Friday and must be completed by 8:30 a.m. on Saturday. Tear down is not allowed until 4:00 p.m. on Sunday.
6. There is no access to electricity.
7. Single spaces are 10x10, Double spaces are 10X20. All spaces are located on relatively level ground. You may view site if you would like to come and see it.
8. State taxes should be collected by all vendors.
9. Vendors must be present rain/shine (serious inclement weather will cancel event) and will be under the discretion of Orr's Farm Market.
10. Following set-up the vendors will be assigned a parking area and must park their vehicles in the correct lot a half-hour before the festival opens each day.
11. Minimal after-hours security will be provided with the understanding that George S. Orr & Sons, Inc. is not and will not be responsible in any way for loss or damage to participant's property. Exhibitors are responsible for their own personal and property liability.
12. George S. Orr & Sons, Inc. cannot be held liable or responsible for loss or damage to work or injury to any person participating in the show. The festival cannot be responsible for weather damage to products. A signed application constitutes a contract to follow all rules and regulations and is a commitment to participate personally if accepted.
13. All Vendors are required to have permits from the Berkeley County Health Dept. if they will be serving samples.
14. Food Vendors must have a Food Permit from the Berkeley County Health Dept and must comply with guidelines applicable to their business.
15. Vendors selling edible products must have proof of liability insurance.
16. Additional vendors may be required to submit proof of liability insurance at the discretion of Nationwide Insurance. This depends on the activity or product at your booth.
17. Clean up-each vendor is responsible for leaving their booth area as found. Any trash must be cleaned up and removed.
18. Restroom facilities will be provided by Orr's Farm Market.
19. There is no alcohol use permitted on or around the festival or concert properties.
20. No pets allowed on or around the festival or concert properties.
21. There is absolutely NO SMOKING in the vendor area except in the designated smoking areas. This is in accordance with Berkeley Co. Health Code. Smokers will be subject to a fine if they do not comply with smoking areas.

**RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT** in consideration of the vendor/artisan area at the Fall Festival located at the property of Mark Orr, Mike Orr, or George S. Orr & Sons, Inc. located at 682 Orr Drive, Martinsburg, WV 25403 on September 24-25, 2016.

I hereby agree as follows:

1. To waive any and all claims that I have or may have in the future against George S. Orr & Sons, Inc., Orr's Farm Market, Mike Orr, Mark Orr, the Fall Festival and their employees and volunteers (all of whom are hereinafter collectively referred to as "the Releasees") and to release the Releasees from any and all liability for any loss, damage, injury, or expense that I may suffer as a result of or arising out of any aspect of my use of the vendor/artisan area due to any cause whatsoever, including negligence or theft; or in respect of the provision of or the failure to provide warnings, directions, instructions, or guidance as to the use of the vendor/artisan area.
2. To hold harmless and indemnify the Releasees from any and all liability for any loss, damage, injury, or expense to any third party, resulting from the use of the vendor/artisan area.
3. This Agreement shall be effective and binding upon my heirs, next of kin, executors, assigns, administrators, and representatives, in the event of my death or incapacity.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.

3. Submit a copy of your General Liability Insurance if you are selling anything edible or if you are bringing an activity for children.
4. Applications along with payment for applicable fees must be received in the George S. Orr & Sons, Inc. office by June 1, 2016.
5. If for some reason you are not selected for participation, any fees will be returned.
6. No electricity is provided.
7. No refunds after July 31, 2016 will be given.
8. Vendors selling food please include a copy of your Berkeley County Food Permit.
