Please fill out the application and mail it to us by May 1<sup>st</sup>

**AGREEMENT**

- All work must be suitable to a family-oriented show. We reserve the right to remove any exhibit not complying with these rules and regulations
- Assigned space will be approximately 10'x10'. If additional area is required, let us know with application.
- Spaces are assigned on a first-come, first-assigned basis.
- Booths are reserved in your name only. Exhibitors cannot sublease booths.
- All exhibitors are expected to provide enough stock for the entire show, set up before show hours and remain open until closing time. All exhibitors must remain open until 5:00 on Saturday and 4:00 on Sunday.
- Set up may begin after 4pm on Friday and must be completed by 8:30 on Saturday. Tear down is not allowed before 4:00 on Sunday.
- There is no access to electricity
- State taxes should be collected by all vendors.
- Items sold in booth will be ONLY as set forth in this application and documented by photos. Resale of items not handcrafted by vendor is forbidden.
- I will furnish my own table(s), Chair(s), and tent, if applicable
- Once unloaded my vehicle(s) will be removed to a parking area designated for artisans.
- I am responsible for the security of all articles in my space.
- This is a rain or shine festival. There will be no refunds for inclement weather
- I hereby and forever discharge Orr's Farm Market and all persons for North Mountain Arts Festival from any responsibility, personal liability, loss and or damage in connection with this festival.
- All food vendors are required to have permits from Berkeley County Health Department if they are serving samples.
- All food vendors must have a Food Permit from the Berkeley County Health Department and must comply with guidelines applicable to their business
- Vendors selling edible products must have proof of liability insurance.
- Clean up-Each vendor is responsible for leaving their booth area as found. All trash must be cleaned up and removed.

**RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT**

I hereby agree as follows;

1. To waive any and all claims that I have or may have in the future against George S. Orr and Sons, Inc., Orr's Farm Market, Mike Orr, Mark Orr, North Mountain Arts Festival and their employees and volunteers (all of whom are hereinafter collectively referred to as "the Releasees") and to release the Releasees from any and all liability for any loss, damage, injury, or expense that I may suffer as a result of or arising out of any aspect of my use of the vendor/artisan area due to any cause whatsoever, including negligence or theft; or in respect of the provisions of or failure to provide warnings, directions, instructions, or guidance as to the use of the vendor/artisan area
2. To hold harmless and indemnify the Releasees from any and all liability for any loss, damage, injury, or expense to any third party, resulting from the use of the vendor/artisan area.
3. This Agreement shall be effective and binding upon my heirs, next of kin, executors, assigns, administrators, representatives, in the event of my death or incapacity.

**I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.**
